4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 1 years residual market life i.e. the offered product shall not be declared end-oflife by the OEM before this period.

3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

4. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

5. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

6. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

7. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

8. Buyer Added Bid Specific ATC

(v) Bidder must submit the undertaking regarding restrictions on Land Border Sharing as per Gol, Ministry of Finance, Department of Expenditure letter No F.7/10/2021-PPD and F.7/10/202 1-PPD all dt 23.02.2023 as per Annexure attached in GeM Bid.. Failure to submit the same, Bid may be rejected.

vi) Payment Term : 100% payment will be made after delivery, installation & satisfactory acce ptance by the user subject to submission of all requisite documents Delivery Challan, Original Tax invoice with mentioning the Institute GST Number 21AAAAI2760A1ZJ, GeM Contract No & date in the Invoice, Warranty Certificate in Original with clearly mentioning the Warranty Per iod started from the date of installation/user acceptance to end of the warranty date, Installat ion Certificate in Original etc.

vii) DELIVERY WITH INSURANCE: The date of delivery should be strictly adhered to failing whic h the purchase order is liable to be cancelled. Penalty may be imposed as per P.O. terms & co nditions. Goods should be securely, safely and adequately packed, insured & dispatched at th e risk of supplier and packing costs quoting this order reference should be kept in all package . Local firms are requested to deliver the goods in our stores before 3.00 PM on any working d ay.

viii) All damaged or unapproved goods shall be returned at your cost & risk and the incidental expenses incurred thereon shall be recoverable from any of your bill.

ix) WARRANTY: Ordered materials should have 01(One) Years onsite OEM Warranty from the d ate of installation/commission & acceptance by the user. In case at the time of installation of s tores / part of stores are found defective / damaged during or after delivery to consignee, the supplier will replace the stores. If the stores / part of stores are found defective / damaged du ring the warranty period, the supplier will repair/replace the stores at consignee's location in I ndia free of cost or if any case it is required to send back to Foreign/Local manufacturer, supp lier should bear the cost. Bank Guarantee equivalent to the cost of equipment is required to b e submitted before lifting the store. All expenses including freight, insurance, custom duty for export/import and all clearance charges etc. in this regard will be borne by the supplier. The e quipment under warranty period must be attended & problems rectified immediately within 4 8 hours of lodging of complaint by the Institute and this may be considered as the down time. The warranty period shall automatically be extended for such period for which the equipment is not attended & rectified on lapses of the down time.

x) Delivery period : Delivery, installation, commissioning & demonstration should be complete d within 60 days from the date of the issue of the GeM Contract.

xi) LIQUIDATED DAMAGES: As time is the essence of this order, the date of delivery, Installati on, Commissioning and demonstration should be strictly adhered to, otherwise the delivery, I nstallation, and Commissioning in full or in part may not be accepted and penalty for late deli very/Installation/ Commissioning will be imposed @ 0.5% of the contract value per week or par t of the week of the delayed period, subject to a maximum of 10% of the total value of supply order & beyond 10% subject to approval of the Competent Authority of the Institute. In case o f cancellation of order no compensation will be paid towards progress of order/procurement.

xii) CANCELLATION: Printed conditions, if any, contained in or sent along with the quotation sh all not be binding on us. IIT Bhubaneswar reserves all the rights cancel the Purchase Order at any stage without assigning any reason thereof.

xiii) JURISDICTION: For any dispute, the place of jurisdiction shall be Bhubaneswar, India only.

xiv) IIT Bhubaneswar reserves the right to accept or reject or cancel any or all enquiries or qu otations/Bid at any stage without assigning any reason thereof.

xv) False declarations will be in breach of the Code of Integrity under Rule 175(1)(i)(h) of the General Financial Rules for which a bidder or its successors can be debarred for up to two yea rs as per Rule 151 (iii) of the General Finance Rules along with such other actions as may be permissible under law.

- 8. Seeking sample with bid or approval of samples during bid evaluation process.

- 11. Creating bid for items from irrelevant categories.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
