APPENDIX-V

RULES RELATING TO ENROLMENT OF MEMBERS OF NON-TEACHING STAFF

(Vide para 2.4 and 2.7 of the Regulation)

- 1. Members of non-teaching staff (working in permanent capacity, including technical and non-technical) may be permitted to join the Ph.D. program of the Institute provided, that prior permission i.e., No Objection Certificate (NOC) has been obtained from the Competent Authority before admission to the program.
- 2. For admission to the program, a member of staff must fulfill the prescribed norms and at the qualifying examination he/she must have obtained at least the percentage of marks/grade/CGPA as prescribed in the Institute Ph.D. regulations. The prescribed minimum qualification for admission to the Ph.D. program and other details are given in the regulations. The candidate need not be a GATE/UGC-NET/CSIR-NET qualified.
- All common rules laid down in the Ph.D. Regulations relating to course work, prosecution of research work under the supervision of a member of faculty, etc. shall be applicable to all members of staff when being enrolled.
- 4. A member of staff enrolled for the Ph.D. degree shall be exempted from payment of any tuition and other fees except the following, which all Ph.D. candidates are required to pay (a) Admission fee, and (b) Thesis fee. Members of staff enrolled for the degree shall not be entitled to any other Scholarship.
- 5. The above para (5) is applicable to MS-R students also.
