


1. The date of auction: 15.04.2024 (Monday) at 11.00 AM.







They will only be allowed to have an inspection in batches by the institute with proper identity proof at the main gate of the Institute and according to SoP of the Institute (SoP for entry of persons is available on Institute Website). Prospective Bidders may Contact Chief Security Officer or Assistant security Officer for getting the permission to enter the main gate of the institute.
8. The Reserve Price for sale of the Cashew Nuts will be fixed by the Committee who will oversee the entire process of auction and will be declared on the auction day before starting auction process.
9. The Bidder who Quotes the highest amount will be offered the order for collection of the Cashew nuts. The Bidder who is considered for order has to deposit the entire sum of their quote or negotiated price in the form of DD or NEFT/RTGS Transfer to Institute. Only after the receipt of the above amount the LoI/Work Order shall be issued to Highest Bidder, failing which the Committee is at liberty to consider next highest Bidder for the award and ... so on.
