

**Scope towards Installation, Testing & Commissioning of Old Split Air Conditioners in Room no-302 of 1st Year Lab Complex of IIT BHUBANESWAR AT ARGUL.**

1. The scope includes identifying both indoor & outdoor Units of old ACs which are in good condition & are stored by the Institute at LCS- 5 inside the campus.
2. The identified AC units have to be shifted (Around 1 Km) by the successful contractor from the existing store to the 1<sup>st</sup> year lab complex.
3. Only IDUs & ODUs will be supplied by the Institute. However, the remaining items like Copper pipes, drain pipes, cables from IDUs to ODUs shall be supplied by the contractor. The dimensions of the Copper pipes & the drain pipes shall be as per the schedule and shall comply with the relevant IS standard.
4. The quantities mentioned in the schedule is tentative, the same may vary at site. The bidders have to inspect the site before installation starts & accordingly the copper pipe & drain pipes are to be supplied at site.
5. Jointing of Copper pipes shall be avoided. However in extreme case as per the site condition, where the length of the copper pipe is more, jointing of the Copper pipes shall be done through Brazing. The accessories required for the Brazing shall be arranged by the contractor within the tendered cost. Proper standard shall be followed by the contractor for Brazing work.
6. During installation, if any valve/flair nuts etc are found damaged, the same shall be replaced with a new one with extra cost based on the market rate.
7. Pressure testing shall be carried out with the help of Nitrogen gas as per the prevailing standard following which vacuuming shall be done after which the gas charging shall be done. In no case, the leakage shall be observed in the copper pipe line between the IDUs & ODUs.
8. Drain pipe line to be supplied & installed at site shall be insulated properly.
9. Refrigerant shall be supplied by the contractor as per the schedule.
10. Civil work like drilling/wall cutting etc is under the scope of the contractor which is required for taking the pipes outside for connection with the ODUs. However, the civil work shall be taken up after taking permission from the Institute & shall be done as per the direction of the Engineer-in charge.
11. The ODUs shall be installed over the roof top. The exact location of the IDUs & ODUs will be decided by the Engineer-in-charge or his representative.
12. After completion of the erection work, the ACs are to be tested & the temperature of the room has to be recoded. In case the cooling will not be effective after the installation due to defects in the old IDUs & ODUs, the defective part shall be replaced by the contractor from the existing spare ACs lying with the Institute.
13. During gas filling, care should be taken by the contractor to avoid gas leakage to the surrounding.

1. **Scope of work:** Details enclosed as **Annexure-I, Annexure-II.**
2. **Consumables/Small items:**  
The rates shall be all inclusive of establishment as well consumables/small items required for the work. The contractor is required to assess the probable quantity of all types of consumables & other small items likely to be required for execution of the work. Nothing extra on account of consumables shall be payable over and above the contract value. Only the valves/flair nuts if required shall be supplied & installed with additional cost as per the market rate.

**15. Performance guarantee:** 5% of Tendered value shall be deposited by the successful bidder in the form of Demand Draft drawn in favour of Registrar, IIT Bhubaneswar payable at Bhubaneswar from any nationalized bank within the period specified in **Schedule-F**. 17. **Security Deposit (SD):** Security deposit @ 5% of the gross value of the work will be deducted from the final bill and kept as security deposit by IITBBS. S.D can be released after 08 months from successful completion of the work to the satisfaction of the Engineer in-charge.
18. **Liquidated Damage:** Liquidated damage @ 0.5% of the tendered value of the work lagging behind per week of delay in completion of the work shall be levied subject to maximum 10% of Contract value.
19. The Bid for the work shall remain open for acceptance for a period of 90 days from the date of opening of bid. If any bidder withdraws his Bid before the said period or issue of letter of intent/acceptance whichever is earlier, or makes any modification in the terms and conditions of the bid which are not acceptable to the Institute, then the Institute shall, without prejudice to any other right or remedy, be at liberty to forfeit the Earnest Money. Further the bidders shall not be allowed to participate in the re-bidding process.
20. **Place of Work:** The entire work is to be taken up at IIT Bhubaneswar campus at Argul, Jatani.
21. **Site Inspection by the Bidders:** The tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of site, the means of access to the site and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools and plants, water & electricity access, facilities for the workers and all other services required for executing the work. The water and Electricity point will only be shown to the contractor from where necessary tapping can be made by the contractor at the time of work execution.
22. **Safety:** All safety measures are to be followed by the successful bidder while execution of the contract & safety standard shall be followed as per IE(Indian Electricity) rule, while working near charged Electrical panel/on Electrical system. The Institute does not hold responsibility for any untoward situation arising out due to violation of safety rules. Work permit shall be obtained from IIT BBS before taking up the work.
23. IITBBS will not be responsible or liable in case of any accidental injury to the personnel of the contractor at work site or to the general public at work site due to mishandling/improper work execution by the personnel of the contractor. Workmen compensation, PF, ESI of the employees shall be taken care by the contractor. IITBBS will not be responsible for the same.
24. After completion of work, area to be thoroughly cleaned by the contractor and the wastes are to be taken out through proper waste management.
25. It will be the sole responsibility of the contractor to abide by the provisions of the following acts as to the workers engaged by him for performance of this contract:
  - Employment of Children Act
  - Workmen Compensation Act
  - Employment of Labour / Contract Labour Act
  - Industrial Employment Act

- Contract Labour Abolition and Regulation Act 1970
  - Minimum Wages Act
  - Employee Provident Fund Act.
  - Any other act or legislation which may govern the nature of the contract.
26. The contractor shall be liable to pay compensation for any loss and damage caused to the property of IIT BBS. The damages made must be rectified by the contractor without any extra cost. In case, the rectification will not be done by the contractor, equivalent amount will be deducted from the Bill. The cost for the same will be assessed by tender accepting authority and will be limited to the tendered amount.
27. **Engineer & Workmanship:** The Engineer/Supervisor/Technician/Helper to be deployed at site must have experience in execution of similar work. They must have expertise in installation of split ACs. If the Institute feels to replace any of the person to be replaced because of any reason, the same must be done by the contractor on intimation from IIT BBS.
28. **Gate Pass:** The contractor must issue/ submit ID proof of all the workers to be deployed at site for entry pass at the time of entry.
29. The successful bidder has to submit the detailed address & contact details (including e-mail address) to IIT BBS for necessary official correspondence after award of the contract.
30. **Risk Purchase:**  
In the event of failure of the contractor to execute the contract to the satisfaction of the Institute, the Institute reserves the right:  
a-To reject any part of the Contract executed and withhold payment for such portion of the Contract till such time the defects are rectified to the satisfaction of the Institute.  
b-To terminate the Contract and to get the Contract executed by other agency at the risk and cost of the contractor.
31. **Personal Accident Insurance:**  
The employees of the contractor will have to be covered under insurance against any personal accident and Institute will not be liable for payment of any compensation on that account. During the execution of work, the contractor shall follow all standard norms of safety measures / precautions to avoid the accident / damages to man, machineries and building. On non-adherence of this clause, suitable fines shall be imposed as decided by engineer in charge, Institute. But, in no case the fine imposed by the Institute exceeds the contract value.
32. The Institute reserves the right to cancel the tender at any time without assigning any reason thereof.
33. Corrigendum /Addendum notice if any, will only be uploaded in the web site of IIT Bhubaneswar [www.iitbbs.ac.in](http://www.iitbbs.ac.in) (Tenders) & in <https://eprocure.gov.in/eprocure/app> . There will be no press publication in this regard. Bidders are required to check the Corrigendum /Addendum notice if any in web site of IIT Bhubaneswar, before finally submitting the bid.
34. **Jurisdiction of the Court:** Dispute/Litigation if any, arising out of this contract, shall be deemed to have been entered into at Bhubaneswar under jurisdiction of Odisha High Court, Cuttack.
